### **TAX FILING & ADJUSTMENTS**

Tax Filing on your total income between 2024/1/1 to 12/31 is obligated for Business owners, Freelancers, Farmers, office employees who have side jobs, and the applicants below:

- Salary exceeds 20 million yen
- Salary from more than one places
- •Furusato Nozei/Hometown Tax program users (except One-stop system users)



Exceeded withheld tax after deductions can be returned. For detailed information, please contact Tax Office. Deductible items are as follows:

•Housing loan deduction program (first year only), Medical expense, Insurance payments etc.,

## When to file: between February 17 to March 17 2025

# Required documents to file tax /claim deduction are as follows:

- 1. Tax Filing form (available at the tax office in your town. See below tax office list.)
- 2. Documents to prove your income (such as: Income tax withholding statement)
- 3. Your Identification documents (such as: Residence card and My-number card)
- 4. Documents to claim eligible dependents deduction (such as: birth certificate of your dependents, proof of remittance to support your dependents in your home country)
- 5. Documents to claim insurance payment deduction (such as: proof of payment issued by the insurance company)
- 6. Documents to claim medical payment deduction (such as receipts issued by medical office and pharmacy)
